REGISTRATION FORM

Pursuant to Section 14-40, Town of Hypoluxo Code of Ordinances any person who does not have a business located within the corporate limits of the Town but comes within the corporate limits of Hypoluxo to carry on, complete, perform or engage in any type of business is hereby required to register with the Town by filling out a registration form. Such person must provide a copy of a valid Local Business Tax Receipt issued by another municipality and/or county for their permanent office and must provide proof of insurance. There is no charge to register if the business is State Certified. A nominal registration fee is charged if a business is not State Certified.
